ORDINANCE NO. 16-72

AN ORDINANCE AMENDING SECTION 1.08.010 OF THE OLATHE MUNICIPAL CODE PERTAINING TO THE DEFINITION OF WARDS IN THE CITY OF OLATHE, KANSAS AND REPEALING THE EXISTING SECTION; ALSO REPEALING SECTIONS 1.08.020, 1.80.030, 1.08.040, AND 1.08.050.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OLATHE, KANSAS:

SECTION ONE: Section 1.08.010 of the Olathe Municipal Code is hereby amended to read as follows:

"1.08.010 Establishment.


- (A) The various wards of the city are established as set out in this section, in Table 1 which lists the precincts contained in each Ward, and in the map in this section.
- (B) If any geographical area in the city is assigned a different precinct number by the Johnson County election office than the precinct number that is described in this section, such geographical area shall continue to be in the same ward as is described in the map in this section.
- (C) If any conflict arises between Table 1 and the map in this section, the map shall prevail.
